ORDER:

The Comprehensive Capacity Building Programme for improved Urban Governance & Poverty Alleviation under the Jawaharlal Nehru National Urban Renewal Mission (JNNURM) envisages for establishment of State/National Resources Centre to enhance the capacities of Urban Managers and to provide policy prescriptions, innovations for better Urban Governance, information and training inputs to all those concerned with improving living conditions and quality of life of urban residents. As per the guidelines of Government of India for establishment of National Resource Centre an extent of Acrs.20.00 of land is required.

2. Government after careful examination of the above proposal, in consultation with Hyderabad Metropolitan Development Authority and Ministry of Housing and Urban Poverty Alleviation, Government of India, hereby permit the Hyderabad Metropolitan Development Authority to allot the land in Sy.No.41/14 of Khanamet Village Serilingampally Mandal, R.R. District to an extent of Acrs.20.00 free of cost, to the Commissioner & Director of Municipal Administration, Andhra Pradesh for establishment of National Institute of Urban Management, Hyderabad as it is well suited for the construction of the Institute in view of its location (proximity) to the City, the development of the surrounding area, and the connectivity.

3. Consequent on orders issued in para 3 above, the same extent of land will be deleted from Resource Mobilisation target of Hyderabad Metropolitan Development Authority.

4. The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority shall take necessary further action in the matter.
