ORDER:-

The proposal for establishment of National Institute of Urban Management at Hyderabad has been under consideration of the Government. The Central Sanctioning and Monitoring Committee (CSMC), New Delhi has approved the proposal to establish National Institute of Urban Management as a National Resource Centre, subject to State Government providing detailed drawing plans, EOI for appointment of architectural consultancy etc and recommended release of 1st installment. To commence the activities of the proposed institute, Government constituted the following committee in G.O. 5th read above, for selection of the Person-in-Charge of the institute and also issued guidelines for selection of Person-in-Charge.

The meeting of the selection committee was held on 25.04.2012 in the chambers of Secretary to Government, Municipal Administration and Urban Development Department for selection of Person-in-Charge (PIC) to the National Institute of Urban Management (NIUM) and the selection committee finally selected Sri K.Bhoopal Reddy, IFS (Retd) for appointment as Person-in-Charge, National Institute of Urban Management.

4. The Government after careful consideration of the recommendations of the selection committee hereby appoint Sri K.Bhoopal Reddy, IFS (Retd) as Person-in-Charge of the National Institute of Urban Management, Hyderabad for a period
