ORDER:

In the G.O. 1<sup>st</sup> read above, orders were issued appointing Sri K.Bhoopal Reddy, IFS (Retd.), as Person-in-Charge, National Institute of Urban Management, Hyderabad for period of one year from the date of taking charge as Person-in-Charge, National Institute of Urban Management and his term of appointment expired on 30.05.2013. The Person-in-Charge, National Institute of Urban Management in his reference 2<sup>nd</sup> read above, while indicating steps being taken to bring the NIUM into full pledged Institute and further works to be taken by the Institute, has requested to take a decision on continuation or otherwise for the post of Person-in-Charge, National Institute of Urban Management for further period.

2. The Commissioner and Director of Municipal Administration, Hyderabad in his letter 3<sup>rd</sup> read above has reported that there is need to continue the Person-in-Charge, National Institute of Urban Management for one more year to take forward the following activities of NIUM.

- To Register the NIUM as per Societies Act and related activities.
- Getting the appropriate Business Plan developed and approved at GOI level for getting release of Rs. 50.00 Crores from HUPA Ministry, GOI.
- Assisting the Hon'ble Minister, MAUD and the team in signing proper MOU with Korea Research Institute for Human Settlements (KRIHS), Korea for the benefit of State of Andhra Pradesh and National Institute of Urban Management as per G.O.Rt.No.374 MA, MA&UD(UBS)Dept., dtd:16.03.2013.
- Hand hold Capacity Building trainings by coordinating with existing training Institutes on one side, and getting the participants from departmental Heads on other side and organizing the trainings.

3. While, the proposal of Commissioner and Director of Municipal Administration is under consideration, in the reference 4<sup>th</sup> read above, Sri K.Bhoopal Reddy, IFS (Retd.), Person-in-Charge, National Institute of Urban Management was directed to continue beyond 30.05.2013 until further orders in order to get NIUM registered under A.P. Societies Registration Act, 2001 (Act. 35 of 2001) and to take up Capacity Building Programme and to impart training to MA & UD Department functionaries.

7. The Commissioner and Director of Municipal Administration, Hyderabad shall take further necessary action.
